2. Guest Speaker: Justine Jackovich

I work as the Assistant Director of Student Life. I work with the RA's. Allison is the area coordinator of the Complex. We will spend a couple of minutes going through the lottery. All the lottery cards were sent out in the mail yesterday. Each has a randomly selected number, anticipated grade, date, and years spent on campus. GPA and involvement are not a part of it. Numbers are randomly designated from there on, the lower number the better. Numbers range between 1-2000. Graduating seniors will be between 1-1000; 3rd year: 1000-1500; 2: 1500 – 2000. If there is a student who has not received their card yet it could be because of a high balance on their account. We get a list of those hold students at the end of every day. We would be happy to discuss with those students. Next Monday is the first night of the lottery. This is for the Res, just to choose which suites. Tuesday will be fore Knights Village for Seniors. Wednesday night is for Singles. Monday the 20th is the 8 and 6 person suites in Lohe and Grossman. Tuesday the 21st is for the 4-person suites Grossman, Lohe, Complex and Waverly Manors. Wednesday the 22nd is for the 2 person suites. This is for efficiency and to respect student's time better. The manors split is for those who don't have suite mates picked. If you have a group of 4 they can sign up for those in the Waverly manors. We ask that students come to the night with the room ideas filled to capacity and have a first choice and then a second and a third. This way they can split and have options still. This is also to respect time. You can let your constituents know that when they are living with other people, the group will average their numbers. The larger suites in Knights, Doubles, and Triples, will happen in Neumann. There will be emails sent out as well as many posters around campus.

Academic Ombudsperson Pollack: If you don't get your card right away, does your number get penalized?

Jackovich: No, numbers are assigned beforehand and held. If you have a friend that is living off campus or studying abroad, they can just talk to Cassie Hales and someone else can pick up their card. Also, during those nights, not everyone has to be present. You need to have at least one representative with all the housing cards.

Vice President-Elect Alene: If the Waverly Manors is filled to capacity, would you direct them to the Afton Manors?

Jackovich: They would have to come the next night. If they have a lower average, they would likely be able to end up together anyway.

President-Elect Jaeschke: How would a person studying abroad access their card?

Jackovich: They can just have a friend pick it up from Cassie Hales.

Senator Cannon: There is a rumor that you can switch your number.

Jackovich: No, you cannot switch your number

Recorder Henderson: I have heard people in the past use the lottery number of a person they know is transferring, what happens to them?

Jackovich: We do our best to keep track of those things but it something that is difficult to keep track of.

Recorder Henderson: Are those suites then kicked out or are they just liable to have a person put with them if Student Life says so?

Jackovich: They would be put on a list and would be filled on an open basis, yes. That room would then be seen available.

Senator Conteh: What if someone fails to attend the lottery?

Jackovich: We will work on reaching out to them but it is important that they come. Mainly because they will have more options. If there is a logistical conflict, their friend can go for them.

Mann: There is also a Facebook page called Wartburg College Roommate Search that can help people fill their suite. Could help fill some spots.

Jackovich: we are always open to talking to people about it, come by the Student Life Office.

Treasurer Jobes-Ryan: Motion to suspend the rules

Senator Brown: Second

The Rules are suspended

Because the timeliness of the request for water bottles for Dance Marathon has preliminarily discussed and suggested 50% which is \$500. In order for Dance Marathon to get their order in on time they need to place the order today and without funding from Senate cannot afford to buy them. As a Senate, preliminarily, what do you think about passing this in the future so that we can let them know whether to place to order today or not at all?

Administrative Ombudsperson Laudner: Why can't we just vote on it today?

Treasurer Jobes-Ryan: I wanted to let committees discuss it and let people think and talk about it. I need to get initial opinions.

Senator Thompson: If we don't vote today then they don't get money?

Treasurer Jobes-Ryan: This would be a reimbursement for them, after we vote. I just want to know if it is likely that this would pass in the future.

Senator Brown: But essentially we do have to come to a definitive decision right now.

Treasurer Jobes-Ryan: We want to come to discussion and don't want to necessarily push it forward.

Senator Revis: What is then the point of discussion in committees?

Vice President Creed: As acting president, do you think we should not vote on this today?

Cannon: If we vote yes today, what will stop other organizations from asking this large amount?

Vice President Creed: They did not ask for us to vote on it today, that is our decision.

Senator Cannon: More about the amount, what will stop other organizations like choirs from asking for large amounts like this?

Treasurer Jobes-Ryan: It is not a large amount, it's \$567 that BRC has suggested. It is not close to the whole amount requested. The \$567 is small in respect to other requests. It is not a concern about other organizations. Kantorei has also asked for a large amount that we will see later on the agenda

President Elect-Jaeschke: The question is asking about how other organizations may come to compare the amount they receive to this.

Treasurer Jobes-Ryan: It is not a fair comparison in that way, like apples to oranges. This is a good cause.

Senator Buckwalter: When we funded water bottles at the beginning it had our logo and we funded them in a three-way split, right?

Treasurer Jobes-Ryan: Yes, in a three-way split. These bottles would have the Dance marathon logo. The request shows 'Custom Design' but that is just to put logos on. This would further sustainability.

Senator Kiersten: Would voting on this early set a precedent for the future? Is there a concern that this may happen again? It is great that this is greener.

Treasurer Jobes-Ryan: It is a combination of the circumstances and timeframe. Also, getting the request over break hindered its speed. The circumstances are unique in the way that if they do not get the funding from Senate then they no longer can follow through with their plans. This was not our first choice of action.

Senator Myers: If we stick with that then we should not vote on that today?

Senator Revis: It seems like a lack of planning. Like many professors have around campus, signs that say "Lack of planning on you part does not constitute an emergency on my part." This needs to be discussed. How much is left in the budget?

Treasurer Jobes-Ryan: We have a little under \$4,000 left in the budget. It is not to say that we need to spend the money because that is what we have left. That is true for professors that it is not their emergency but it is our job to assist the organizations. There are guidelines but there are also times where acceptations are appropriate.

Vice President Creed: Do we want to vote on this? We need to move on.

Recorder Henderson: What is the minimum amount of funding they need to still be able to do this?

Treasurer Jobes-Ryan: \$420

Senator McMichael: Why do we have to move on, this seems to be a pretty important thing that needs to be discussed?

Vice President Creed: Because I am leading this meeting and we have other New Business that needs to be talked about.

Treasurer Jobes-Ryan: We can vote on this today if that is what Senate decides. We can accept or reject BRC's suggestion.

Vice President Creed: We will vote on this today. Do we amend this or no?

Administrative Ombudsperson Laudner: Do we need to motion first, then vote? I motion to amend this request to \$567, per BRC's recommendation.

Treasurer Jobes-Ryan: We can vote to amend it.

Vice President Creed: There has been a motion to amend this request to \$567.

Professors Everbrook and Nolan got moved up to full time professors also. Retention is at 89%, which is better than sister institutions and public universities.
